ADMISSION NOTICE FOR CLASS XI-2021-2022

Applications are invited for admission in the following streams for the academic year 2021-22.

- 1) Science stream with subject combinations:
 - (a) English, Physics, Chemistry, Mathematics and Computer Science
 - (b) English, Physics, Chemistry, Mathematics and Biology
 - (c) English, Physics, Chemistry, Computer Science and Hindi
 - (d) English, Physics, Chemistry, Biology and Hindi
- 2) Commerce stream with subject combinations:
English, Hindi, Economics, Business Studies and Accountancy
- 3) Humanities stream with subject combination English, Hindi ,
History, geography , and Economics

General Eligibility – Passed / Qualified class X from a recognized board.

For NON-DAE

- i) Admission in science : A minimum of 55% marks aggregate in class X
- ii) Admission in Commerce : A minimum of 45% marks aggregate in class X
- iii) Admission in Humanities stream: A minimum of 40% marks in aggregate in class X

Note – Admission will be granted as per the availability of seats according to the merit. In case of a tie, marks obtained Science, Maths & English will be considered. If the tie still persists, the older candidate will be given preference.

The information given by the candidate in the form submitted will be verified with their original documents at the time of admission. If found incorrect, the admission shall stand cancelled

Documents to be submitted at the time admission:

1. A passport size photograph to be pasted on the admission form.
2. Photocopy of the mark sheet / print out of marks statement can be downloaded from CBSE website.
3. Caste certificate (SC/ST) from the competent authority (SDO/ Tahsildar) will be acceptable only.
4. T.C duly countersigned by DEO/ appropriate authority (in case of school affiliated to other than CBSE) needs to be submitted during admission for students other than Jaduguda centres.
5. Undertaking by self and by UCIL employee (Annexure -1 & Annexure -2) in case of Non-DAE applicants must be submitted to declare the payment of fees on time & that in case they fail to pay the fees before the due date, the same amount shall be deducted from his / her salary.

Note:

1. Preference will be given to DAE wards & students under TNP/SEEP.
2. Admission under Non-DAE category shall be at the discretion of the management and subject to availability of the seat only.
3. Non-DAE students shall be defined and restricted to the pass out of AEC Schools and their admission will be as per AEES norms.
4. Admission of the Non-DAE applicant irrespective of schools from which they passed out shall be treated as new admission.
5. An undertaking by parents must be submitted as given below. "I am not going to claim any concession. This will be treated as new admission and revised fee shall be paid accordingly as prescribed for Non DAE applicant." I shall pay the amount for the whole at the time of admission. Undertaking form(ANNEXURE I and II) is available with admission form.
NOTE: Annexure (I) and (II) undertaking must be submitted with form duly signed by parents regarding payment of fees for NON- DAE candidate and its strict adherence.
6. Parent will follow all the fee rules applicable to his/her ward as per AEES norms and pay the fees within the stipulated time frame. If not able to follow the undertaking signed by him /her school administration is free to take action as per school admission rules/AEES Admission guidelines for fee defaulters.
