This has reference to your letter No. AEES/AU/CBSE/Affn./2019-20/2636 dated 10.10.2019 on the subject cited above. In this connection, I am directed to inform you that as per chapter-II, rule 2.1.1 to 2.1.10 of Affiliation Bye-Laws-2018, the Board affiliates different categories of schools all over India and abroad. The relevant extract is given below:-

In this connection, in the light of the above rule position and approval of the Competent Authority, I am directed to inform you that all the Atomic Energy Central Schools fall under Independent category as per clause 2.1.5 of Affiliated Bye-Laws, 2018.

Further, the category of all the Atomic Energy Central Schools has been changed as Independent (General) along with change of their affiliation numbers. Details enclosed for reference. The schools would now quote its new affiliation numbers in all the future correspondence. All the schools may also be directed to update their OASIS data immediately as per their new affiliation numbers to avoid any inconvenience in future.



Sub : Uniform fees structure in Senior Secondary Sections of all Atomic Energy Central Schools/ Atomic Energy Junior Colleges – reg.

Instances have been reported to Central Office, AEES that the fees collected from the students of Classes XI and XII under different heads of account is varying from one AEC School/Junior College to another. In order to maintain the uniformity in the fees structure for the students of Classes XI and XII of all AEC Schools/Junior Colleges, a committee was constituted by AEES to review the present fees structure of each AEC School/Junior College being charged from the students of Class XI and XII and to furnish its recommendations. The said committee after its review has submitted its recommendations which were placed before the Governing Council of AEES in its 172nd meeting held on 17/05/2017 with a request to approve the same.

2. Governing Council of AEES after examining the said recommendations of the duly constituted committee has accorded approval to adopt the fees structure with a direction to AEES that this uniform fees structure be implemented for the students seeking admission in Class XI from the Academic Year 2017-18 onwards. Council also directed AEES that this will enable all the AEC Schools and Junior Colleges to maintain the uniformity among the senior secondary sections of all AEC Schools and Junior Colleges, irrespective of the Board to which these classes are affiliated. As for the students who are presently in Class XII (i.e. for the academic year 2017-18), the fees structure for these students will be based on the existing rates when they sought admission in Class XI in the academic year 2016-17.

3. In compliance with the said directives of Council, all the Heads of AEC Schools and Junior Colleges are advised to adopt this approved fees structure for the students of Class XI from the beginning of this Academic Year 2017-18, and in respect of students of class XII for the Academic Year 2017-18, the fees will be collected from them as per the rates existing for the year 2016-17. However, the fees so collected from Class XI and Class XII students shall be remitted in the Head of Account as shown in col. No. 5 of the table given below.

4. All Heads of AEC Schools/Junior Colleges are requested to follow the aforesaid fees structure respect of the students seeking admission in Class XI from the Academic Year 2017-18 onwards. The Vice Principals concerned and dealing assistants of each School/Junior College be informed about the change the fees structure while charging the fees from the students of Class XI seeking admission for the academic year 2017-18. From the next academic year (i.e. 2018-19) onwards, these uniform rates as brought out the aforesaid table are to be made applicable for the students of Classes XI and XII to enable all the AEC Schools and Junior Colleges to maintain the uniformity in the fees structure.

5. A compliance report in this regard be forwarded by all Heads of AEC Schools and Junior Colleges to this office latest by 31/07/2017.


